#### **Exhibitor Information: Schooling Allowed, Weather Permitting, at Discretion of Show Management.**

*Each Horse/Rider combination shall only school in one schooling session per Ring. Be ready to school during break. We will not hold the schooling for any reason.*

\*Hunt Team is open to all. Teams of three horses or ponies to follow single file at a safe hunting distance except for last fence, which must be jumped three abreast. Animal limited to one team only. \*Field Hunters is open to any horse who has hunted 5 or more times.

\*Jumpers (**OPEN TO ALL**): Table II, 2.1 —The first round is decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. Horses with clean rounds or equal faults are classified according to their time taken to complete the course.

Table II, 2.b —The first round and first jump-off, if any, are decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. If a competitor has gone clean in the first round, the competitor will, without leaving the ring, upon an audible signal, commence the designated jump-off. If there are no clean rounds and a tie exists for first place, there will be one jump-off in which time will decide in the event of equality of faults.

**If entries warrant we may split/combine divisions at the discretion of the show**

# **ELKRIDGE-HARFORD HUNT CLUB HORSE AND PONY SHOW REPRESENTATION, ASSUMPTION OF RISK AND RELEASE AGREEMENT**

I, the undersigned rider, hereby sign the following representation and release in consideration of being permitted to ride in one or more classes in a horse show conducted by the Elkridge-Harford Hunt Club, Inc. on property owned by Harford Holding Company and sanctioned by the Harford Horse Show Association, Inc. and the Baltimore County Horse Show Association, Inc., hereinafter collectively referred to as the "Organizer".

I hereby certify that I fully understand that riding is inherently dangerous to the participants and that there is serious possibility that I will suffer injury or death as a result of participation. I hereby state that I have been given notice of the risks of riding in and otherwise participating in horse activities, including, but not limited to, (i) the propensity of an equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an equine's reaction to sound, movements, objects, persons, or animals; and (iii) hazards of surface or subsurface conditions. I expressly agree to assume all of the above described risks and all other risks of riding in and otherwise participating in the horse show. I certify that I am over 18 years of age, or, if not, my parent has signed where indicated below.

In order to induce the above described Organizer to allow me to participate in such horse show, I represent that I am properly trained and competent to ride in such horse show without endangering myself or other participants. I further represent that the horses I will ride are properly trained for the endeavor and will provide a safe conveyance without unduly jeopardizing my safety or that of others. I further certify that I have examined and thoroughly inspected the course and its periphery and am familiar with any adverse ground conditions. I recognize that other unanticipated adverse conditions may arise during the course of the event.

I further certify that I am currently covered by a health insurance policy; OR I am currently covered by a Worker's Compensation insurance policy; and that such insurance shall remain in effect at all times that I am participating in the horse show. I will, upon request, provide proof of such insurance prior to being allowed to ride.

As further inducement to the Organizer to allow me to ride in and otherwise participate in the horse show, I agree to release, hold harmless and fully indemnify the Organizer, their committees, committee members, officers, directors, employees, agents, volunteers, officials and other persons acting on behalf of the Organizer from any and all liability, claims, actions, causes of action or demands, including attorneys' fees and costs, that I might otherwise have or assert for any injury or other claim or other matter arising out of or related to my riding in or otherwise participating in the horse show, (including claims arising from any negligence of the Organizer) and I further agree to release, hold harmless and indemnify all landowners on whose land the above described horse show are conducted from any and all liability, claims, actions, causes of action or demands, including attorneys' fees and costs, that I might otherwise have or assert for any injury or other claim or other matter arising out of or related to my riding in or otherwise participating in the horse show.

And I further waive any and all claims, actions, causes of action or demands that I may now have or which may arise in the future, and further covenant not to sue the above named Organizer or persons, including landowners, for any injury or damages resulting from my participation in such horse show.
