## Harford Horse Shows Association, Inc.

## BY-LAWS

#### I. Name

As adopted by a plurality vote of the executive committee, the association's name shall be: Harford Horse Shows Association, Inc. ("HHSA").

## II. Purposes

The purposes of the HHSA, Inc. shall be:

- To stimulate interest in the sport of horse showing.
- To provide healthy competition and sportsmanship among exhibitors registered with the HHSA
- To promote quality English horse shows.
- To encourage the growth of the number of exhibitors attending local English horse shows.
- To support the financial cause of the organizations or groups that hold local English horse shows.

## III. Members

#### Section 1 - Membership

- A. Membership in the HHSA is not restricted to place of residence.
- B. Senior members are members over 18 years of age as of 12/1 of the previous year.
- C. Junior members are members 17 years of age and under as of 12/1 of the previous year.
- D. Non-riding members are members of any age who do not ride for points, but wish to be a part of the HHSA and have voting privileges.

#### Section 2 - Registration

- A. Membership fee will be announced prior to each show season.
- B. Payment of membership fee enrolls the voting member for one show season and the Fall Open meeting following that show season.
- C. Tabulation of points will be effective as of the date of registration.
- D. Animals are to be registered separately.

#### Section 3 - Voting

- A. Only senior members may nominate and vote for members to serve on the Board of Directors.
- B. Only junior members may nominate and vote for a maximum of 6 junior board members to serve one-year terms.

## IV. Operating Procedures

#### Section 1 - Committee Elections

- A. At an annual final meeting, open to all HHSA members, a majority of present registered voting members in good standing will elect Adult directors to serve for a three (3) year term.
- B. There shall be nine (9) Adult directors on the board of directors. Beginning in 2007, the first year

after implementation of this rule, three directors will be elected to three-year terms, three directors will be elected to two-year terms, and three directors will be elected to one-year terms. Thereafter, elections for those directors whose terms are expiring will be for three-year terms. Junior members may nominate and vote for a maximum of six (6) junior board members to serve one-year terms.

- C. Members may serve consecutive terms on the board of directors.
- D. Any Director who misses three (3) meetings of the board of directors in a one-year period shall be removed as a director.
- E. The Board of Directors, in addition to the nine (9) directors referred to above, shall include the officers referred to in Section 3. In addition, the past president shall be offered the opportunity to sit on the Board of Directors.

#### Section 2 - General Committee Powers

- A. Only Adult members of the Board of Directors shall be eligible to vote. A simple majority of the Adult members must be present for official business.
- B. The Board of Directors shall serve to conduct and manage the affairs of the HHSA for the current year.
- C. It shall establish the divisions in which riders and equines compete.
- D. The Board of Directors shall maintain records of competing members and recorded horses and ponies.
- E. It shall make or suggest amendments, additions, or deletions to these rules subject to membership approval by majority vote of members in good standing at an open meeting.
- F. However, in extenuating circumstances, and when deemed for the benefit of the membership, the committee will have the power to amend, add, or delete a rule mid-season but may not make a permanent rule unless approved by a majority vote of members in good standing at the next open meeting.
- G. It shall publish a calendar of HHSA associated shows for the current year.
- H. The Board of Directors shall make decisions (by majority vote) on issues not covered by these rules.

#### Section 3 - Officers

- A. Officers of the HHSA shall include, but not be limited to, a President, Vice President, Secretary and Treasurer, who shall be voted to their positions by the voting members of the association in good standing. The term of each office shall be two years. In order to serve as President, the individual must have served on the board for at least one year within the prior three years as a director.
- B. The President shall be an Adult member and shall preside at all meetings of members and directors at which he/she shall be present and shall perform duties as may be assigned to him/her by the Board of Directors. The president shall appoint sub-committees that he/she deems necessary for the proper conduct of the HHSA.
- C. The Vice President shall be an Adult member and in the absence of the president shall preside at all meetings and shall perform all other duties of the president. He/she shall have such powers and perform such duties as assigned to him/her by the Board of Directors.
- D. The Secretary shall be an Adult member and shall give notice of all meetings of the Board of Directors, keep minutes for all executive and open meetings, possess a current mailing list, and perform such duties as assigned by the President.
- E. The Treasurer shall be an Adult member and shall collect all monies due the association and have the care and custody of all funds, receipts, and disbursements. Funds shall be deposited in the

name of the HHSA, Inc., in a bank that is most convenient for the Treasurer. He/she shall render to the President and Board of Directors an account of the financial condition at all meetings. Only receipts deemed proper by the Board of Directors shall be accepted for reimbursement. The Treasurer shall be responsible for filing annual tax material.

#### Section 4 - Vacancies

A. Vacancies of the HHSA Board of Directors may be filled by a majority vote of the Board of Directors.

#### Section 5 - Point Tabulator

- A. The President will appoint an individual to assume the duty of point tabulator.
- B. The point tabulator will record and tabulate all points earned by registered members and animals.
- C. All show managers must forward Judge's Cards, or copies of same, to Point Tabulator within seven (7) days following show.
- D. A penalty of \$50.00 will be assessed if the Horse Show does not submit show data as indicated in Section 5 (C) above.
- E. All show results will be kept for three (3) years by HHSA

#### Section 6 - Open Meetings

- A. The purpose of open meetings is to inform the general membership of current policy and to ascertain general membership approval of that policy by majority vote of members present.
- B. Open meetings will be conducted under simplified "Roberts Rules of Order."
- C. Members will be notified of open meetings through electronic communication and/or individual mailings.
- D. At least two (2) open meetings per year will be held with fair notice.
- E. All permanent rule changes must be voted on at the Spring Open Meeting.
- F. All members must be advised of proposed rule changes prior to the Spring Open Meeting.

## V. Infractions

#### Section 1 - Protests

- A. An exhibitor, agent, trainer, or parent of a junior member for any violation of the rules may make a protest to the Board of Directors. The protest must be:
  - i. In writing.
  - ii. Signed by the protestor.
  - iii. All protests must have written documentation/evidence turned in to support protest within seven (7) days of filing or the Board of Directors, with automatic forfeit of deposit, will automatically dismiss the protests.
  - iv. Addressed or submitted to the Secretary of the HHSA
  - v. Accompanied by a deposit of \$100.00 and received by the Secretary within seven (7) days of the alleged violation of which, \$20.00 will be non-refundable.
- B. Protests requiring immediate attention will be taken to the show steward for a decision, which must be made in accordance with HHSA rules.
- C. In the event the steward cannot reach a decision in regard to a protest, he/she must request a hearing through the HHSA committee.
- D. Such hearings shall be held within ten (10) days' notice to the concerned parties. All persons concerned shall be notified and may, at their option, attend the hearing and may bring witnesses,

sworn statements, or other evidence in their own behalf. After the hearing, if the protest is upheld, final penalty will be handed down by the HHSA Board of Directors.

- E. If the protest is overruled, the entire deposit will be forfeited to the HHSA. If the protest is sustained, the deposit, less the \$20.00 non-refundable fee, shall be returned to the protestor and a fee of \$80.00 shall be assessed to the party found in violation.
- F. No prizes shall be awarded/collected at end of the season if any outstanding fee is unpaid.
- G. If fees are unpaid by the following show season, those members shall be subject to censure, suspension, expulsion or forfeiture as outlined in Article V. Infractions, Section 3.

#### Section 2 - Violations of Members

- A. Inspecting the judge's card without the permission of the judge is a violation.
- B. No member may approach a judge before or after a decision without first obtaining permission from the show steward or the Board of Directors.
- C. Cruelty to or the abuse of a horse by any person at an HHSA sanctioned event is forbidden and renders the offender subject to penalty. The Show Committee must bar violators from further participation for the remainder of the competition. It is the duty of the show committee and steward to report to the Board of Directors any person who indulges in this practice for such further action as may be deemed appropriate. Abuse includes, but is not limited to: excessive use of a whip on any horse in a stall, runway, schooling area, competition ring or elsewhere on the competition grounds, before, during or after a competition, by any person; and inhumane treatment of a horse in a stall, runway, schooling area, competition ring or elsewhere on the competition grounds, by any person.
- D. No one will be allowed to physically or verbally assault another person.
- E. Members must obey penalties imposed by the HHSA
- F. Riding, exhibiting, coaching, or training for the benefit, credit, reputation, or satisfaction of a suspended person is prohibited.
- G. Any violations (for which members may be subject to penalty) not covered by this set of guidelines, but which may occur and necessitate action by the committee, will be judged according to standards prescribed in the current Recognized Show Rules.

#### Section 3 - Penalties

- A. *Censure* Formal notification in writing and published in the HHSA newsletter recognizing that an offense has been committed and by whom.
- B. *Suspension* The inability to participate in any form at any HHSA function, i.e. as an exhibitor, spectator, or participant. The period of suspension shall be at the discretion of the HHSA Adult executive committee. The terms of the suspension shall be published in the HHSA newsletter.
- C. *Expulsion* The person(s) receiving expulsion from the HHSA will be unable to participate in any form in HHSA sponsored functions permanently. The expulsion shall be a formal notification in writing and published in the newsletter.
- D. *Forfeiture* The person involved in the offense must return all trophies, ribbons, and prize money in connection with offense committed. Of the points earned by the involved person or animal, HHSA will take those connected to the offense off the HHSA point book.
- E. The Board of Directors of the HHSA shall be responsible for deciding which penalty is appropriate for a violation of the HHSA rules

## Harford Horse Shows Association, Inc. R U L E S

*If a rule or regulation is not clearly stated within this rulebook, HHSA will default and adhere to the rules and regulations standard to the United States Equestrian Federation (USEF).* 

## I. Exhibitor Information

#### Section 1 - Calendar Year

A. All eligibility will be determined as of 12/1 of the previous year. This includes both horse and rider eligibility.

#### Section 2 - Registration

- A. All animals are registered for the current show season for a set fee, which will be announced before the first HHSA show of the current year.
- B. All animals, in order to compete in the HHSA Medal Finals, must be registered with HHSA by June 1 and have shown in at least one (1) HHSA pointed division prior to the year-end medal finals in the same year. If the animal is registered after June 1, a \$20.00 late fee will be charged on top of the set horse membership fee.
- C. HHSA recorded animals are eligible for awards in all divisions for which they qualify.
- D. Registration forms must be filled out and all fees paid before any points will count. Forms must be filled in with complete information to ensure correct awarding of points and inclusion on HHSA associated shows' mailing lists.
- E. HHSA will not be responsible for errors made because of failure of the exhibitor, owner, agent, or trainer to complete the registration form correctly or to adhere to the responsibilities described in these guidelines, or to show an animal as registered.

#### Section 3 - Measurement

- A. All ponies must have a current HHSA issued card or a current Maryland Horse Show Association (MHSA), Virginia Horse Show Association (VHSA), Baltimore County Horse Show Association (BCHSA) or United States Equestrian Federation (USEF) issued measurement card.
- B. Cards will be available at each registered show.
- C. A committee designated by the HHSA Board of Directors will do measuring. Ponies shall be measured shod or unshod.
- D. MHSA, VHSA, or USEF measurement cards shall take precedence.
- E. All ponies must be measured for a current card before they can show.

#### Section 4 - Divisions

HHSA recognized shows might offer any or all of the following divisions:

#### Section 5 - Exhibitor Responsibilities

- A. Exhibitors are required to use the same name for their mounts at every show.
- B. Exhibitors are required to wear the correct number.
- C. Rider's name must be included on entry blanks. Adults (18 years of age or older) must sign entry forms.

- D. All exhibitors are required by Maryland law to show proof of a negative coggins test for any equine brought to the show grounds. It must be current within twelve (12) months of the date of the show.
- E. All ponies must have a valid measurement card.
- F. Juniors and seniors may show the same horse at the same show, when eligible.
- G. Exhibitors should be familiar with the requirements of point tabulation.
- H. HHSA registered shows will set a 3-minute time limit when calling a class. Gate person, ring person, and/or announcer must be notified of any legitimate tack change or class conflict. Elimination from the class will result if this procedure is not followed. Exhibitors should make every effort to help the show keep moving.
- I. Exhibitors will leave the show grounds clean of trash and other debris (including stones or wood used to block trailer tires) and manure, shavings, or other bedding.
- J. If the exhibitor has a question for the judge, see the HHSA By-Laws, Rule V. "Infractions", section 2, Point B.
- K. Judges should not be harassed or insulted.
- L. Unruliness, profanity, or any other serious loss of control by an exhibitor will be penalized.
- M. Any exhibitor who is in debt to an HHSA show or HHSA itself will not be allowed to participate in any HHSA functions until all debts are paid in full.
- N. Martingales are prohibited in all under saddle classes and Pleasure divisions.
- O. Stallions are prohibited from the grounds at HHSA shows.
- P. Proper Attire:
  - i. Anyone mounted must wear approved hard hats and proper footwear with heels.
  - ii. All riders must wear, while mounted, a helmet approved by SEI and/or ASTM, with safety harness fastened.
  - iii. All exhibitors must be neatly and appropriately attired for their respective riding classes, including tack (i.e. riding coat, riding shirt, riding boots, appropriate bits, appropriate bridles, appropriate saddles, etc., for hunter and pleasure).
  - iv. Chaps are not allowed except in the Low Hunter division.
- Q. Senior riders may ride ponies only in the Low Adult Amateur Hunter, Pre-Children's/Pre-Adult Hunter, Hopeful Hunter, Equitation, and Green divisions.
- R. All hunters must be serviceably sound without exceeding the legal level limits of medications; i.e., such animals must not show evidence of lameness or broken wind.
- S. All animals exhibiting in over fences classes must trot at least one-half the opening circle. If there is no opening circle on a particular course, they shall trot approximately 40-feet, either before beginning to canter the course or at the conclusion of the course to allow the judge to assess soundness. Any animal determined by the judge to be unsound, or which fails to trot as described above, shall be excused from the class as soon as possible.
- T. Any animal in an under saddle class determined to be unsound by the judge shall be excused from the class as soon as possible. The Judge shall further determine whether the animal is disqualified only for the class, for example, if the unsoundness is caused by stepping on a stone or hitting a jump; or for the duration of the show. The judge's decision as to soundness is final.
- U. Consumption of alcoholic beverages is prohibited at all HHSA sanctioned shows.

## II. Show Management

#### Section 1 - Show Registration & Dates

- A. Each participating show will pay a \$175.00 registration fee.
- B. HHSA will make every effort to help make the show successful, but cannot guarantee profits or be held responsible for conditions beyond its control.

- C. Dates of shows will be arranged to the satisfaction of show management and the HHSA
- D. The last show of the year will be sponsored by the HHSA committee and will be held no later than 10/31 of the current year.
- E. Cancellation of the shows will require that the show committee notify exhibitors registered with the HHSA within 21 days of the proposed show.
- F. Unless a definite rain date is printed on the program, shows will be held rain or shine. A show that would like the option of cancellation in case of rain must include a phone number to call the morning of the show. Show management may cancel a show in the case of emergency or extraordinary circumstances. Management must use its best efforts to advise members of any such change.
- G. Shows may be held outside Harford County, Maryland with the permission of the committee. The committee will consider the number of shows, the location, and the expected quality of the show.
- H. All shows must submit a class list to the committee for approval at least 30 days prior to the show. This class list must have the names of the judges and the steward. Failure to do so may result in the forfeiting of HHSA pointing for the show.
- I. Any dates loaned by HHSA must be done in writing, and borrower must pay all fees to HHSA
- J. When HHSA is participating in a "bi-pointed show", the rule book that will be followed, including classes/divisions and jump heights, for that show will be that of the PRIMARY association of the hosting facility.

#### Section 2 - Judges

- A. The hiring of a judge or judges of the show is the responsibility of the show management.
- B. Judges must be Registered, Recorded or Learner Judge of the USEF or MHSA
- C. No judge may officiate more than three (3) times in HHSA pointed shows in any show year, nor may any judge officiate more than once in any twenty (20) day period.
- D. A judge may not judge the same division at the same show for two (2) consecutive years.
- E. Exceptions will be made for extenuating circumstances, which must be cleared by that years' governing board.

#### Section 3 - Stewards

- A. The HHSA Board of Directors shall appoint a steward for each member show from a list of qualified stewards maintained by the Board.
- B. A steward should clearly understand that he/she has no authority in connection with the management or the judging of a competition, but should point out in a diplomatic manner any instance where Association rules are not enforced.
- C. He/she should immediately report to the appropriate officials any violations of the rules that might invalidate a class.
- D. He/she should keep themselves available to judges, exhibitors, and management at all times to clarify the application of Association rules and investigate any situation where the rules are not upheld.
- E. HHSA Board of Directors will appoint a non-partisan steward for the Special Equitation Medal Finals.
- F. The other duties of a steward shall be, but are not limited to, the following:
  - i. To protect the interests of exhibitors, judges and competition management.
  - ii. To investigate and act upon any alleged rule violations without waiting for a protest.
  - iii. To report to the show committee misrepresentation or substitution of entry without waiting for a protest.
  - iv. To determine when and if the Judges should be asked to excuse jackets for excessive heat.
  - v. To notify exhibitors in classes where, due to a violation, points will not count toward the year-end awards.

- vi. To determine when a show shall be stopped due to darkness, storm, or other emergency.
- vii. To excuse any horse and/or rider from the show grounds, in conjunction with the Board of Directors for the HHSA and the Show Management.

## III. Show Standards

#### Section 1 - General

- A. The entry booth is required to be open and in operation at least 45-minutes prior to show time.
- B. Grounds shall be open at least one (1) hour prior to show time.
- C. Only proper equipment and authorized personnel are permitted in the show ring while a class is in progress.
- D. The point tabulator shall have free access to the entry booth and all pertinent information he/she might need during the running of the show.
- E. Every pointed show is required to offer a Harford Hunter Seat class and a USET class.
- F. Each show must award ribbons through 6th place.
- G. In any under saddle class in a pointed division, if there are twenty (20) or more entries, the class must be split and held in at least two sections with one set of awards. The class will be split using a method specified by the judge. Only one section shall be in the ring at a time, except as may be required to split the class. If conditions warrant, the class may be divided at a lower number of entries at the judges' discretion.
- H. In any merited class, the minimum number of entries required to split a class is twelve (12), unless the class is held in an indoor facility, in which case the class must be split at twelve (12). All other merited classes must be split if the number of entries is eighteen (18) or more.
- I. In any pointed division, if there are thirty-nine (39) or more entries, the class is to be split and two (2) sets of ribbons are to be awarded.
- J. Pre-Children's/Pre-Adult Hunter must be split at eighteen (18) entries with two (2) sets of ribbons awarded.

#### Section 2 - Rings

- A. Rings must be made of wood, snow fence, or other proper material as approved by the HHSA committee. Non-acceptable material includes electric wiring, bailing twine, roping, etc.
- B. Rings must be of a suitable size to handle classes held therein safely.

#### Section 3 - Jumps

- A. Hunter and pleasure fences must be twelve-feet (12') in width if wing standards are not available. However, wing standards are strongly recommended as a safety feature. Proper attachments must be easily adjustable to the proper height.
- B. Hunter fences shall simulate obstacles found in the hunt field, i.e. post & rails, brush, stone wall, white board fence, gate, Aiken, chicken coop, hedge, etc. Pleasure fences should simulate obstacles found on the trail. A ground line is strongly recommended for all fences.
- C. All rails must be of solid wood.
- D. Jumps may have a maximum deviation of three-inches (3") lower but never higher than regulation height (at the show committee's discretion).

#### Section 4 - Schooling Area

- A. An area must be provided and contain at least two (2) schooling fences with proper poles and proper attachments.
- B. It must be available to exhibitors one (1) hour prior to show time.
- C. Two (2) schooling sessions shall be provided in each ring.

D. Each show's respective show management will govern schooling breaks.

## IV. Annual Awards

- A. Year-end points will become final two (2) weeks after the final show of the season.
- B. Each year a permanent award and eight (8) ribbons are presented to the high point earners in each of the HHSA divisions.
- C. For Leadline, a Blue Merit award will be given when the rider has accumulated twenty (20) points. At that point, HHSA will no longer record points in that division for that rider. Riders must accumulate at least ten (10) points in order to receive a Red Merit in the Leadline division and five (5) points for a Yellow Merit.
- D. In the Mini Stirrup Equitation and Short Stirrup Equitation divisions, the riders will receive a Blue Merit award when they have accumulated forty-five (45) points. After the rider has reached forty-five (45) points, no additional points will be tabulated. Mini Stirrup Equitation and Short Stirrup Equitation riders who accumulate at least twenty (20) points but less than forty-five (45) points will receive a Red Merit award.
- E. In the Long Stirrup Equitation division, the riders will receive a Blue Merit award when they have accumulated forty-five (45) points. After the rider has reached forty-five (45) points, no additional points will be tabulated. Long Stirrup Equitation riders who accumulate at least thirty (30) points but less than forty-five (45) points will receive a Red Merit award.
- F. In any Hunter division, no under saddle points will count towards year end awards unless the animal also completes a course in an over fences class in the same division at the same show.
- G. If the animal is leased, the lease may be transferred between persons during the year without affecting the animal's score.
- H. In the event of a tie, a high score award will be given to each of the tied competitors for year-end awards.
- I. Two classes in each division are necessary for points in that division to count for HHSA annual awards.
- J. In order for a horse and rider to qualify for a year-end prize, they must ride in three HHSA shows in the same division and have earned at least ten (10) points in that same division during the show season. In any show, horse and rider must be a member in order for points to be counted.
- K. Any exhibitor who wins a perpetual trophy at either the Benefit Show or the Annual Awards Banquet is responsible for the prompt return of the trophy in the same condition as it was received. An adult (18 years of age or older) must sign a receipt for the trophy before it can be removed from HHSA possession. The receipt shall specify the date the trophy is to be returned to the trophy coordinator.
- L. Any exhibitor failing to return the trophy by the date specified by the trophy coordinator will be assessed a late fee of \$150.00. Any member who fails to return a Benefit Show trophy by the Wednesday preceding the Benefit Show of the following year shall forfeit all points accumulated by the member and any animals owned by the member during the show season. Those members shall also be barred from participating in the Benefit Show and the Medals Finals of that season. Any member failing to return a year-end perpetual trophy by November 1st shall forfeit all points accumulated by the member and any animals owned by the member during the show season.
- M. To be eligible to receive an HHSA High Points Show Series Trophy, performance horses, performance ponies, or equitation riders must have shown in at least two out of three shows managed by the HHSA Show Committee at the Harford County Equestrian Center.

Harford Hunt Seat Equitation Medal – Child on a Pony Donated by the Pyle Family Presented annually to the first (1<sup>st</sup>) place junior rider in this special class. Junior riders must qualify for the ride-off held at the Medal Finals at the end of the season. Ribbons will also be awarded to eighth (8<sup>th</sup>) place.

Harford Hunt Seat Equitation Medal – Child on a Horse *Donated by the Pyle Family* 

Presented annually to the first (1<sup>st</sup>) place junior rider in this special class. Junior riders must qualify for the ride-off held at the Medal Finals at the end of the season. Ribbons will also be awarded to eighth (8<sup>th</sup>) place.

USET Equitation Medal

Donated by Mr. Richard Rhia

Presented annually to the first  $(1^{st})$  place adult rider in this special class. Adult riders must qualify for the ride-off held at the Medals Finals at the end of the season. Ribbons will also be awarded to eighth  $(8^{th})$  place.

Presented to the OTTB with the most points in all performance divisions. To be eligible for any of the HHSA year-end Thoroughbred awards, a horse must have proof of Jockey Club registration, state breed association membership, or a visible tattoo. The owner (or leaser) of the horse must be a registered member with HHSA and the horse must be recorded with HHSA, with proof of Thoroughbred eligibility on file with HHSA.

#### ARABIAN/PART-ARABIAN HIGH POINT AWARDS:

The Aazrak Memorial Perpetual Trophy

Donated by the friends of Ann McKay

Presented to the registered Arabian or part-Arabian (minimum 25% Arabian blood) horse or pony with the highest total points in all performance classes.

#### **BENEFIT SHOW AWARDS:**

The HHSA Best Merit Rider

Donated by Harford Horse Shows Association

Awarded to the best merit member at the HHSA Benefit Show, as chosen by the judges and the HHSA committee. They will be chosen on the basis of riding skills and ability at the HHSA Benefit Show.

#### The HHSA Best Child Rider on a Pony

Donated by Harford Horse Shows Association

Awarded to the best junior member on a pony at the HHSA Benefit Show, as chosen by the judges and the HHSA committee. They will be chosen on the basis of riding skills and ability at the HHSA Benefit Show.

The HHSA Best Child Rider on a Horse

Donated by Harford Horse Shows Association

Awarded to the best junior member on a horse at the HHSA Benefit Show, as chosen by the judges and the HHSA committee. They will be chosen on the basis of riding skills and ability at the HHSA Benefit Show.

#### The HHSA Best Adult Rider

Donated by Harford Horse Shows Association

Awarded to the best adult member at the HHSA Benefit Show, as chosen by the judges and the HHSA committee. They will be chosen on the basis of riding skills and ability at the HHSA Benefit Show.

#### SCHOLARSHIP AWARDS:

The Lisa Hess Memorial Scholarship

Each year HHSA will award a \$500.00 scholarship to a graduating high-school senior. A 500-word essay will be submitted to the Board of Directors. Only high-school seniors graduating in that calendar year are eligible. The scholarship will be awarded to the member in the fall of that year. A check from the HHSA Treasurer will be sent directly to the college of their choice.

#### SPORTSMANSHIP AWARDS:

The Howard F. Jefferson Memorial Sportsmanship Perpetual Trophy Donated by Diplomat Title Presented to the junior member of the HHSA who exhibits outstanding sportsmanship.

#### The Senior Sportsmanship Perpetual Trophy

Donated by the Earnest Family in memory of the ultimate good sport, Country Blazer Presented to the adult member of the HHSA who exhibits outstanding sportsmanship.

The Junior and Adult Sportsmanship award is to be awarded to a member respectively, nominated by the membership and selected by the members of the Sportsmanship Award Committee, based on the following criteria:

- A. Must be an active member in good standing of the Harford Horse Shows Association, Inc. and is inclusive of both riders and non-riders.
- B. Demonstrates and exemplifies the ideals of sportsmanship consistently throughout the show season, including but not limited to:
  - Integrity
  - Good character
  - Respect for themselves, their mount, fellow competitors as well as others
  - Demonstrate a positive attitude (grace) when faced with adversity
  - Promotion of the sport either in the saddle or on the ground
  - Fairness
  - Civility
  - Honesty
  - Respect for the rules that govern our sport as well as judge's decisions

*Nominations*: Nominations are to be made using the "Nomination Form." This form must be completed in its entirety in order to be accepted by the Sportsmanship Award Committee. These forms will be placed at the entry booth for each show. They will be mailed back to the chairperson who will, in turn, share and review with the other members of the Committee.

*Committee Selections*: Each member of the governing board will nominate a person to serve on the Sportsmanship Award Committee. Three to four (3-4) Committee members will be chosen by lottery from the nominees suggested by the governing board. The President of the governing board will act as chairperson for this committee.

*Review of Nomination Forms*: The recipient of the award will be chosen based on the review of the nomination forms by the Sportsmanship Award Committee. The name will be presented to the board prior to the Year-End Awards Banquet. The recipient(s) will receive their award at the Year-End Awards Banquet

## VI. Points

#### Section 1 - General Information

A. Points will be as follows:

- B. There must be at least three (3) entries in a class for full points to count towards year-end awards.
- C. In the event that there are only two (2) entries in a class, the class may be held but only half points will be awarded and count towards year-end awards. A class must have a minimum of two (2) entries in order to run and any points be awarded toward year-end awards.
- D. Double points may be allowed by the Board of Directors at HHSA shows; and any double pointed show must be advertised in advance.
- E. No additional points will be awarded for champion and/or reserve champion ribbons.
- F. Shows are encouraged to tabulate and award championships in all divisions.

#### Section 2 - Point Inquiries

A. Point standings will be posted on the www.hhsamd.org website. If you have any questions concerning your points for the show season, contact pointkeeper@hhsamd.org or submit an inquiry through the HHSA website.

## VII. Amateur Rule

#### Section 1 - Eligibility

Regardless of one's equestrian skills and or accomplishments, a person is an AMATEUR for all competitions who, after his/her 18<sup>th</sup> birthday, has not engaged in any of the following activities which would make him/her a PROFESSIONAL:

- A. Accepts remuneration for riding, driving, showing in halter/in hand, training, schooling or conducting clinics or seminars.
- B. Accepts remuneration for giving instructions in equitation or horse training. (Persons acting as counselors at summer camps, who are not hired in the exclusive capacity of riding instructors and persons giving instruction and training to the handicapped are excluded.)
- C. Accepts remuneration for employment in other capacity (i.e., secretary bookkeeper, veterinarian, groom, farrier) and gives instruction, rides, drives, shows in halter/in hand, trains or schools horses, other than horses actually owned or leased by him/her, when his/her employer or a member of the family of said employer or corporation which a member of his/her family controls, owns, boards or trains said horses.
- D. Accepts remuneration for the use of his name, photograph, or other form of personal association as a horseman in connection with any advertisement or article to be sold.
- E. Accepts prize money in equitation or showmanship classes.
- F. Rides, drives, or shows in halter/in-hand in competitions, any horse for which he/she or a member of his/her family controls, receives remuneration for boarding, training, riding, driving, or showing in halter/hand.
- G. Gives instruction to any person or rides, drives, or shows in halter/in-hand in competitions any horse, for which activity another person in his/her family or corporation which a member of his/her family controls will receive remuneration for the activity.

#### Section 2 - Exemptions

The following activities do not affect the AMATEUR status of a person who is otherwise qualified:

- A. The writing of books or articles pertaining to horses.
- B. Accepting remuneration for officiating as a judge, steward, technical delegate, course designer, announcer or participating as a TV commentator, or accepting bona fide remuneration for services as a veterinarian, groom, farrier, tack shop operator or breeder, or for accepting bona fide remuneration for boarding services.
- C. Accepting remuneration for expenses without profit.
- D. Accepting a token of appreciation, other than money, for riding, driving or showing in halter/inhand. (Note: Horse board, prize money, partial support or objects of more than \$300.00 are considered remuneration, not small tokens of appreciation. Accepting any amount of money, whether more or less than \$300.00, is considered remuneration.)
- E. Having the occupation of veterinarian, groom, farrier, or owning a tack shop or breeding or boarding stable in itself, does not affect the amateur status of a person who is otherwise qualified.

## Harford Horse Shows Association, Inc. DIVISION RULES & DESCRIPTIONS

## I. Equitation Divisions

All ages of riders are determined as of 12/1 of the previous year. In equitation classes, only the rider is being judged, specifically on hands, seat, and control of mount. Therefore, any horse or pony that is suitable for a particular style of riding and is capable of performing the required routine is acceptable. Any rider not having control of his/her mount shall be dismissed from the ring and shall be disqualified from that class. No martingales will be allowed in the under saddle/flat phase of any equitation division or class. In case of a tie for champion in an equitation division, a ride-off will be held to determine the champion and/or reserve.

Once an exhibitor in the Leadline, Mini Stirrup, Short Stirrup, or Long Stirrup Equitation divisions has accumulated the number of points required to earn a Blue Merit award, points are no longer tabulated, but the exhibitor remains eligible to continue competing in that division. See page 14, Section IV, Points C-E, for merit award information.

#### Leadline

Open to junior riders ages 7 and under as of 12/1 of the previous year that have not earned a Blue Merit award in the Mini Stirrup division in the current competition year. Mounts are not to exceed 14.2 hands. The use of grazing reins is permitted in grass rings. Riders will not be allowed to trot. Leadline mounts need not be registered for points to count in this division. To be judged on rider's hands, seat, and suitability of mount. Leadline entries may not cross enter into any other division at the same show. See page 14, Section IV, Points C-E, for merit award information.

#### Leadline

To be shown at a walk both ways of the ring. Pony to be judged 50% on suitability to rider. Riders are to be judged 50% on hands, seat, and control.

#### Leadline Walk

To be shown at a walk both ways of the ring. Pony to be judged 50% on suitability to rider. Riders are to be judged 50% on hands, seat, and control. Riders may be escorted without penalty as long as the pony or rider is not touched.

#### **Mini Stirrup Equitation**

Open to junior riders ages 10 and under as of 12/1 of the previous year. Mounts are not to exceed 14.2 hands. The use of grazing reins is permitted in grass rings. Mini Stirrup Equitation mounts need not be registered for points to count in this division. Mini Stirrup Equitation riders in this division may only cross enter into Beginner Rider Equitation at the same show. (\*Please note that cross-entering into Beginner Rider Equitation is permitted <u>ONLY</u> at HHSA governed shows. Cross-entering into Beginner Rider Equitation is <u>NOT</u> permitted at shows where another association is the governing association.) See page 14, Section IV, Points C-E, for merit award information.

#### Mini Stirrup Equitation Walk

To be judged at a walk both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Mini Stirrup Equitation Walk-Trot

To be shown at a walk and trot both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Mini Stirrup Walk-Trot Pony

To be shown at a walk and trot both ways of the ring. To be judged on suitability of the mount as a Mini Stirrup Pony. Ponies' manners are to be emphasized.

#### Mini Stirrup Equitation Over Fences

To be shown over four (4) 12" x-rails around the outside of the ring at the trot or canter, rider's preference and not to be penalized. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### **Beginner Rider Equitation**

Open to junior and Adult Amateur riders who are not jumping higher than x- rails at the same show. Open to horses and ponies. Adult Amateurs may ride ponies. This division is not intended for green horses or ponies. A rider is <u>not</u> eligible to compete in this division if they have competed over a course of fences 2' or higher at any horse show. Beginner Rider Equitation is a pointed division. Riders competing in this division may only cross enter into HHSA merited divisions at the same show (this includes Mini Stirrup Equitation, Short Stirrup Equitation, and Long Stirrup Equitation) so long as they are not jumping higher than x-rails at the same show. \*Please note that cross-entering is permitted <u>ONLY</u> at HHSA governed shows. Cross-entering is <u>NOT</u> permitted at shows where another association is the governing association.

#### Beginner Rider Equitation Walk

To be judged at a walk both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Beginner Rider Equitation Walk-Trot

To be shown at a walk and trot both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Beginner Rider Equitation Walk-Trot Hunter

To be shown at a walk and trot both ways of the ring. To be judged 50% on rider's hands, seat, guidance, control, and suitability of mount and 50% on the horse or pony's movement and their suitability as a Beginner Rider Equitation mount. Horses' and Ponies' manners are to be emphasized.

#### Beginner Rider Equitation Over Fences

To be shown over a course of four to eight (4-8) 12" x-rails (Show Management's discretion for how many jumps.) at the trot or canter, rider's preference and not to be penalized. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Short Stirrup Equitation

Open to junior riders ages 10 and under as of 12/1 of the previous year. Short Stirrup Equitation mounts may not exceed 14.2 hands. Short Stirrup Equitation is a merited division. Short Stirrup Equitation mounts need not be registered for points to count in this division. Riders may only cross-enter into the Short Stirrup Hunter & Beginner Rider Equitation at the same show. (\*Please note that cross-entering into Beginner Rider Equitation is permitted <u>ONLY</u> at HHSA governed shows. Cross-entering into Beginner Rider Equitation is where another association is the governing association.) See page 14, Section IV, Points C-E, for merit award information.

#### Short Stirrup Equitation Walk

To be shown at a walk both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Short Stirrup Equitation Walk-Trot

To be shown at a walk and trot both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Short Stirrup Equitation Walk-Trot-Canter

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Short Stirrup Equitation Over Fences

To be shown over four to eight (4-8) fences in the ring not to exceed 18" in height (Show Management's discretion for how many jumps). Simple courses are suggested. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Long Stirrup Equitation

Open to junior and senior riders ages 11 and older as of 12/1 of the previous year. Junior riders ages 9 and 10, as of 12/1 of the previous year, that ride a mount exceeding 14.2 hands are also permitted to ride in this division. This division is intended to be for older beginner riders and riders not yet able to show in regular pointed divisions. This division is not intended to be used for schooling green mounts. Long Stirrup Equitation is a merited division. Long Stirrup Equitation mounts need not be registered for points to count in this division. Riders may only cross enter into Long Stirrup Hunter & Beginner Rider Equitation at the same show. (\*Please note that cross-entering into Beginner Rider Equitation is permitted <u>ONLY</u> at HHSA governed shows. Cross-entering into Beginner Rider Equitation is <u>NOT</u> permitted at shows where another association is the governing association.) See page 14, Section IV, Points C-E, for merit award information.

#### Long Stirrup Equitation Walk

To be shown at a walk both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Long Stirrup Equitation Walk-Trot

To be shown at a walk and trot both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Long Stirrup Equitation Walk-Trot-Canter

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### Long Stirrup Equitation Over Fences

To be shown over four to eight (4-8) fences in the ring not to exceed 2' in height (Show Management's discretion for how many jumps). Simple courses are suggested. To be judged on rider's hands, seat, guidance, control, and suitability of mount.

#### **Novice Equitation**

Open to junior and senior riders who have not won three (3) blue ribbons in any open equitation class (excluding 4-H, Mini Stirrup Equitation, Short Stirrup Equitation, and Long Stirrup Equitation) as of 12/1 of the previous year. Eligibility determined as of the first HHSA sanctioned show of that year. Seniors may ride ponies. To be judged on hands, seat, and control of mount. Division consists of one hack and one over fences class, with fence heights 2' or 2'6" offered.

#### Novice Equitation Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, general position, and control of mount.

#### Novice Equitation Over Fences

To be shown over approximately eight (8) fences. Fence heights offered are 2' or 2'6", at the rider's discretion. To be judged on rider's hands, seat, legs, general position, and control of mount.

#### Equitation 13 & Under

Open to junior riders ages 13 and under as of 12/1 of the previous year. To be judged on rider's hands, seat, and control of mount. Division consists of one hack and one over fences class, with fence heights 2' and 2'6" offered.

#### Equitation 13 & Under Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, general position, and control of mount.

#### Equitation 13 & Under Over Fences

To be shown over approximately eight (8) fences. Fence heights offered are 2' or 2'6", at the rider's discretion. To be judged on rider's hands, seat, legs, general position, and control of mount.

#### Equitation 14-17

Open to junior riders ages 14 and older, but not yet 18, as of 12/1 of the previous year. To be judged on rider's hands, seat, and control of mount. Division consists of one hack and one over fences class, with fence heights 2'3'', 2'6'' and 3' offered.

#### Equitation 14-17 Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, general position, and control of mount.

#### Equitation 14-17 Over Fences

To be shown over approximately eight (8) fences. Fence heights offered are 2'3", 2'6" or 3', at the rider's discretion. To be judged on rider's hands, seat, legs, general position, and control of mount.

#### Adult Equitation

Open to senior riders ages 18 and older as of 12/1 of the previous year. Seniors may ride ponies. To be judged on hands, seat, and control of mount. Division consists of one hack and one over fences class, with fence heights 2'6" and 3' offered.

#### Adult Equitation Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on rider's hands, seat, general position, and control of mount.

#### Adult Equitation Over Fences

To be shown over approximately eight (8) fences. Fence heights offered are 2'6" or 3', at the rider's discretion. To be judged on rider's hands, seat, legs, general position, and control of mount.

#### II. Pleasure Divisions

Championships will be awarded to the two (2) horses or ponies accumulating the most points in their divisions. All classes are counted equally toward championships. In case of a tie, the exhibitors must have a hack-off to determine the winner.

#### Small-Medium Pleasure Pony

Open to ponies 13.2 hands and under of any breed suitable for English pleasure riding, exhibited only by juniors. All ponies must be serviceably sound and are to be shown in English tack. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but shall not necessarily eliminate, any entry not having such qualification. Martingales are prohibited in all Pleasure classes. To be judged on performance, willingness, and their ability to give a safe and comfortable ride, with an emphasis on manners. Extreme speed shall be penalized. An entry may be judged for soundness on the pleasure circle. Fence height is 2'.

Small ponies showing in this division may not compete in any other division where fences are 2'3" or higher, except equitation and medal classes, at the same show. Medium ponies showing in this division may not compete in any other division where fences are 2'6" or higher, except equitation and medal classes, at the same show.

#### Small-Medium Pleasure Pony Over Fences

To be shown over a minimum of six (6) fences, not to exceed 2' in height. To be judged on manners, soundness, willingness, suitability to purpose, and natural ability to jump.

#### Small-Medium Pleasure Pony Combination

To be shown at a walk, trot, and canter on a light rein both ways of the ring. At least eight (8) competitors, if available, to jump a minimum of two (2) fences not to exceed 2'. To be judged on manners, soundness, willingness, and suitability to purpose.

#### Small-Medium Pleasure Pony Under Saddle

To be shown at a walk, trot, and canter on a light rein both ways of the ring. To be judged on manners, soundness, willingness, and suitability to purpose.

#### Large Pleasure Pony

Open to ponies over 13.3 hands, but do not exceed 14.2 hands, of any breed suitable for English pleasure riding, exhibited only by juniors. All ponies must be serviceably sound and are to be shown in English tack. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but shall not necessarily eliminate, any entry not having such qualification. Martingales are prohibited in all Pleasure classes. To be judged on performance, willingness, and their ability to give a safe and comfortable ride, with an emphasis on manners. Extreme speed shall be penalized. An entry may be judged for soundness on the pleasure circle. Fence height is 2'.

Large ponies showing in this division may not compete in any other division where fences are 2'9" or higher, except equitation and medal classes, at the same show.

#### Large Pleasure Pony Over Fences

To be shown over a minimum of six (6) fences, not to exceed 2' in height. To be judged on manners, soundness, willingness, suitability to purpose, and natural ability to jump.

#### Large Pleasure Pony Combination

To be shown at a walk, trot, and canter on a light rein both ways of the ring. At least eight (8) competitors, if available, to jump a minimum of two (2) fences not to exceed 2'. To be judged on manners, soundness, willingness, and suitability to purpose.

#### Large Pleasure Pony Under Saddle

To be shown at a walk, trot, and canter on a light rein both ways of the ring. To be judged on manners, soundness, willingness, and suitability to purpose.

#### Pleasure Horse

Open to horses over 14.2 hands, of any breed suitable for English pleasure riding, exhibited by juniors or seniors. All horses must be serviceably sound and are to be shown in English tack. Martingales are prohibited in all Pleasure classes. To be judged on performance, willingness, and their ability to give a safe and comfortable ride, with an emphasis on manners. Extreme speed shall be penalized. An entry may be judged for soundness on the pleasure circle. Fence height is 2' with a 2'6" option.

Horses showing in this division are able to show in all other divisions EXCEPT those divisions where jump height is 3' at the same show.

#### Pleasure Horse Over Fences

To be shown over a minimum of six (6) fences, not to exceed 2'6" in height. To be judged on manners, soundness, willingness, suitability to purpose, and natural ability to jump.

#### Pleasure Horse Combination

To be shown at a walk, trot, and canter on a light rein both ways of the ring. At least eight (8) competitors, if available, to jump a minimum of two (2) fences, not to exceed 2'6' in height. To be judged on manners, soundness, willingness, and suitability to purpose.

#### Pleasure Horse Under Saddle

To be shown at a walk, trot, and canter on a light rein both ways of the ring. To be judged on manners, soundness, willingness, and suitability to purpose.

## III. Hunter Divisions

In hunter divisions, the animal will be judged on soundness, performance, manners, even hunting pace, way of going, and style of jumping together with faults. A hunter course should be a reasonable test for a hunting animal with obstacles simulating those found in the hunt field. Divisions will consist of at least two (2) over fences classes and an under saddle class.

Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability.

It is up to the discretion of the show management as to whether soundness is to be judged by trotting on the hunter circle or jogging back at the end of the class. In case of jogging back, all animals must be jogged back in the same complete bridle as shown in that same class.

No under saddle points will count towards year-end awards unless the animal also completes a course in an over fences class in the same division at the same show.

The champion and reserve champion shall be awarded to two (2) of the four (4) exhibitors that have acquired the most points over fences. In case of a tie score, the championship and/or reserve shall be awarded to the exhibitor that has accumulated the most points over fences. If exhibitors have an equal number of points over fences and no points under saddle, the tied exhibitors shall be hacked off.

#### Short Stirrup Hunter

Open to ponies 14.2 hands and under. Open to riders who are eligible to compete in the Short Stirrup Equitation division at the same show. Short Stirrup Hunter ponies must be registered for points to count. Ponies are allowed to cross enter into any class where eligible. Riders may only cross enter into the Short Stirrup Equitation division at the same show, with the only exception being Short Stirrup riders who have accumulated sufficient points to earn a Blue Merit award in Short Stirrup Equitation. Short Stirrup riders who have earned a Blue Merit award in Short Stirrup Equitation and Novice Equitation at the same show. Riders may not show in Short Stirrup Equitation and Novice Equitation at the same show. Manners and suitability of the pony to the rider shall be emphasized. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 18".

#### Short Stirrup Hunter Over Fences

To be shown in the ring over four to eight (4-8) fences at 18" in height. Simple courses are suggested. To be judged on manners, soundness, way of going, and performance.

#### Short Stirrup Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Long Stirrup Hunter

Open to ponies and horses. Open to riders who are eligible to compete in the Long Stirrup Equitation division at the same show. Long Stirrup Hunter mounts must be registered for points to count. Mounts are allowed to cross enter into any class where eligible. Riders may only cross enter into the Long Stirrup Equitation division at the same show, with the only exception being Long Stirrup riders who have accumulated sufficient points to earn a Blue Merit award. Long Stirrup riders who have earned a Blue Merit award in Long Stirrup Equitation may enter Long Stirrup Hunter and Novice Equitation at the same show. Riders may not show in Long Stirrup Equitation and Novice Equitation at the same show. This division is not intended to be used for schooling green animals. Manners and suitability of the mount to the rider shall be emphasized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'.

#### Long Stirrup Hunter Over Fences

To be shown in the ring over four to eight (4-8) fences at 2' in height. Simple courses are suggested. To be judged on manners, soundness, way of going, and performance.

#### Long Stirrup Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### **Green Pony Hunter**

Open to ponies 14.2 hands and under, exhibited by a junior or senior. A green pony is a mount of any age that meets the criteria following. Ponies may only show in this division for two (2) years if they are otherwise eligible. A pony eligible for this division may exhibit in the under saddle class <u>ONLY</u> without breaking its green status. However, no under saddle points will count toward year-end awards unless the pony also completes a course in an over fences class in the same division at the same show. Ponies may simultaneously show in any other division. Green ponies do not gallop. Simple change of lead shall not be penalized. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'.

A first-year green pony has never been shown over fences of any height, with the exception of Mini Stirrup Equitation, Short Stirrup Equitation, Beginner Rider Equitation, and Special Hunter, in any show prior to 12/1 of the current competition year.

A second-year green pony has only ever shown one (1) year and has never been shown over fences of the regulation pony hunter jump height or higher (equitation and merited divisions included) for its respective size prior to 12/1 of the current competition year.

A first year green pony that wished to maintain eligibility for a second year will not be eligible to compete in green pony in its second year if it jumps above the following jump heights:

- Small Pony may never have jumped 2'3" or higher in any show
- Medium Pony may never have jumped 2'6" or higher in any show
- Large Pony may never have jumped 2'9" or higher in any show

#### Green Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2' in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Green Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2' in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Green Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Green ponies do not gallop. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Small-Medium Pony Hunter

Open to ponies 13.2 hands and under, exhibited by a junior. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'.

#### Small-Medium Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2' in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Small-Medium Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2' in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Small-Medium Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Large Pony Hunter

Open to ponies over 13.2 hands, but not exceeding 14.2 hands, exhibited by a junior. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'6".

#### Large Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Large Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Large Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Small Regular Pony Hunter

Open ponies 12.2 hands and under, exhibited by a junior. This division may be combined with Medium Pony Hunter if there are less than three (3) entries in either division. Manners and suitability of pony shall be emphasized. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'3".

#### Small Regular Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'3'' in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Small Regular Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'3" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Small Regular Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Medium Regular Pony Hunter

Open ponies over 12.2 hands, but not exceeding 13.2 hands, exhibited by a junior. This division may be combined with Small Pony Hunter if there are less than three (3) entries in either division. Manners and suitability of pony shall be emphasized. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'6".

#### Medium Regular Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Medium Regular Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Medium Regular Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Large Regular Pony Hunter

Open ponies over 13.2 hands, but not exceeding 14.2 hands, exhibited by a junior. Manners and suitability of pony shall be emphasized. Suitability of a pony to the rider shall be determined by height and weight of the rider as related to the size of the pony, as well as the compatibility of the rider and pony. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'9".

#### Large Regular Pony Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'9" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Large Regular Pony Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'9" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Large Regular Pony Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Special Hunter

Open to both horses and ponies who are not jumping higher than x-rails at the same show exhibited by Juniors, amateurs, and seniors/professionals. This division is intended for green horses or ponies. To be judged on performance, manners, and soundness. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of a Walk-Trot under saddle class, Walk-Trot-Canter under saddle class, and two (2) over fences classes. Trotting the course and/or simple change of lead shall not be penalized. Fence height is 12" x-rails.

Riders competing in this division may not cross enter into any merited division (Leadline, Mini Stirrup Equitation, Short Stirrup Equitation, or Long Stirrup Equitation) at the same show. Horses/Ponies competing in this division may not cross enter into any other division at the same show.

#### Special Hunter Walk-Trot

To be shown at a walk and trot both ways of the ring. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Special Hunter Walk-Trot-Canter

To be shown at a walk, trot, and canter both ways of the ring. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Special Hunter Over Fences – Two (2) Classes

To be shown in the ring over four to eight (4-8) fences at 12" x-rails in height (Show Management's discretion for how many jumps.) at the trot or canter, rider's preference, and not to be penalized. Simple changes of lead are not to be penalized. To be judged on manners, soundness, way of going, and performance.

#### Hopeful Hunter

Open to horses and ponies, exhibited by juniors and seniors. Seniors may ride ponies. Manners and suitability of mount shall be emphasized in all classes. To be judged on performance, manners, and soundness. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Simple changes are permitted and will not be penalized. Fence height is approximately 2' to 2'3".

#### Hopeful Hunter Over Fences

To be shown over a minimum of six (6) fences approximately at 2' to 2'3" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Hopeful Handy Hunter Over Fences

To be shown over minimum of six (6) fences approximately at 2' to 2'3" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Hopeful Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Pre-Children's/Pre-Adult Hunter

Open to horses and ponies, exhibited by juniors and Amateurs. Amateurs may ride ponies. Seniors competing in classes restricted to Amateurs must meet the requirements of USEF's rule GR1306. A rider in the Pre-Children's/Pre-Adult Hunter division is not eligible to cross enter in any other division where the fence height exceeds 2'3" at the same show except for age group Equitation and Medal classes. To be judged on performance, soundness, and way of going. Division will consist of at least two (2) over fences classes and an under saddle class. Simple changes are permitted and will not be penalized. Fence height is approximately 2' to 2'3".

#### Pre-Children's/Pre-Adult Hunter Over Fences

To be shown over a minimum of six (6) fences approximately at 2' to 2'3" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Pre-Children's/Pre-Adult Handy Hunter Over Fences

To be shown over minimum of six (6) fences approximately at 2' to 2'3" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Pre-Children's/Pre-Adult Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Low Hunter

Open to horses over 14.2 hands, exhibited by juniors and seniors. Riders and mounts may cross enter into any other division where eligible. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence heights offered are 2'6" and 2'9" at the rider's discretion.

#### Low Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6" or 2'9" in height, at the rider's discretion, in the ring. To be judged on manners, soundness, way of going, and performance.

#### Low Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" to 2'9" in height, at the rider's discretion, in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Low Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### **Baby Green Hunter**

Open to horses over 14.2 hands, exhibited by juniors and seniors. A baby green horse is a horse of any age in its first or second year of showing over fences. \*Horses that have shown in the Special Hunter division will continue to be eligible to show in this division. A horse eligible for this division may go in the under saddle class <u>ONLY</u> without breaking its pre-baby green status for the year. However, no under saddle points will count toward year-end awards unless the pony also completes a course in an over fences class in the same division at the same show. Cross entering is eligible into any other division at the same show as long as the animal does not jump higher than 2'6". Baby green horses do not gallop. Simple courses aresuggested and horses may trot their courses without being penalized. Division will consist of at least two

(2) over fences classes and an under saddle class. Fence heights offered are 2'3" or 2'6" at the rider's discretion.

#### Baby Green Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'3" or 2'6" in height, rider's discretion, in the ring. To be judged on manners, soundness, way of going, and performance.

#### Baby Green Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'3" or 2'6" in height, rider's discretion, in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Baby Green Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Baby green horses do not gallop. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Thoroughbred Hunter

Open to horses over 14.2 hands of the Thoroughbred breed <u>ONLY</u>, exhibited by juniors and seniors. Riders and mounts may cross enter into any other division where eligible. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence heights offered are 2'6" and 3' at the rider's discretion.

This is a Thoroughbred <u>ONLY</u> division. Thoroughbred-only divisions may be held at HHSA shows throughout the season. To be eligible for any of the HHSA year-end Thoroughbred awards, a horse must have proof of Jockey Club registration, state breed association membership, or a visible tattoo. The owner (or leaser) of the horse must be a registered member with HHSA and the horse must be recorded with HHSA, with proof of Thoroughbred eligibility on file with HHSA.

#### Thoroughbred Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6'' or 3' in height, at the rider's discretion, in the ring. To be judged on manners, soundness, way of going, and performance.

#### Thoroughbred Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" or 3' in height, at the rider's discretion, in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Thoroughbred Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Baby green horses do not gallop. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Low Children's Hunter

Open to horses over 14.2 hands, exhibited by juniors. Horses are allowed to cross enter into any other class where eligible. The same horse and rider combination may not cross enter into classes where the fence height exceeds 2'9", except Equitation and Medal classes at the same show. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'6".

#### Low Children's Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Low Children's Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### *Low Children's Hunter Under Saddle*

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Low Adult Amateur Hunter

Open to horses and ponies, exhibited by Amateurs. Seniors competing in classes restricted to Amateurs must meet the requirements of USEF's rule GR1306. Horses and ponies are allowed to cross enter into any other class where eligible. The same mount and rider combination may not cross enter into classes where the fence height exceeds 2'9", except Equitation and Medal classes at the same show. Any senior Amateur rider may ride a horse in the Low Adult Amateur Hunter under saddle class and not be subject to the fence height restrictions, provided that the horse has jumped in at least one of the Low Adult Amateur Hunter over fences classes at the same show. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 2'6".

#### Low Adult Amateur Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'6" in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Low Adult Amateur Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'6" in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Low Adult Amateur Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### **Children's Hunter**

Open to horses over 14.2 hands, exhibited by juniors. Horses are permitted to be shown in any other division where eligible at the same show, and not necessarily by a junior. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 3'.

#### Children's Hunter Over Fences

To be shown over a minimum of six (6) fences at 3' in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Children's Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 3' in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Children's Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Adult Amateur Hunter

Open to horses over 14.2 hands, exhibited by Amateurs. Seniors competing in classes restricted to amateurs must meet the requirements of USEF's rule GR1306. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence height is 3'.

#### Adult Amateur Hunter Over Fences

To be shown over a minimum of six (6) fences at 3' in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Adult Amateur Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 3' in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Adult Amateur Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### Green Horse Hunter (discontinued in 2017 season until further notice)

Open to horses over 14.2 hands, exhibited by juniors and seniors. A first year green horse is a horse of any age that is showing at 2'9" fence height and has not previously jumped at that height or any higher heights in previous years. A second year green horse is a horse showing at 3' fence height for the current year that has not previously jumped at that height or any higher heights in previous years. Any horse that shows as a second year green horse will lose his green status the following year. Green horses are not to gallop. . Division will consist of at least two (2) over fences classes and an under saddle class. Fence heights are first year at 2'9" and second year at 3'.

#### Green Horse Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'9" or 3', per horse's respective year, in height in the ring. To be judged on manners, soundness, way of going, and performance.

#### Green Horse Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'9" or 3', per horse's respective year, in height in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Green Horse Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Green hunter horses do not gallop. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

#### **Open Hunter**

Open to horses over 14.2 hands, exhibited by juniors and seniors. Manners and suitability shall be emphasized in all classes and extreme speed shall be penalized. Suitability of a mount to the rider shall be determined by height and weight of the rider as related to the size of the mount, as well as the compatibility of the rider and mount. Judges may penalize, but not necessarily eliminate, an entry not having such manners and suitability. Division will consist of at least two (2) over fences classes and an under saddle class. Fence heights offered are 2'9" and 3', at the rider's discretion.

#### Open Hunter Over Fences

To be shown over a minimum of six (6) fences at 2'9" or 3' in height, at the rider's discretion, in the ring. To be judged on manners, soundness, way of going, and performance.

#### Open Handy Hunter Over Fences

To be shown over minimum of six (6) fences at 2'9" or 3' in height, at the rider's discretion, in the ring or on an outside course. To be judged on manners, soundness, way of going, and performance, with an emphasis on handiness and promptness. There should be two (2) changes of direction and preferably one (1) combination. Entries may be required to trot one (1) fence.

#### Open Hunter Under Saddle

To be shown at a walk, trot, and canter both ways of the ring. Eight (8) or more entries, if available, may be asked to hand gallop one at a time. To be judged on manners, soundness, way of going, and performance. Martingales are prohibited.

## IV. Merit Equitation Special Medal Classes

All animals, in order to compete in any of the HHSA Medal Finals, must be registered with HHSA by 6/1 of the current competition year and have shown in at least one (1) HHSA pointed division prior to the yearend medal finals in the same competition year. If the animal is registered after 6/1, a \$20.00 late fee will be charged in addition to the set horse-recording fee.

Horses and ponies may only exhibit with one rider at the equitation medal finals. <mark>Additionally, each rider will only be eligible to ride in one division at the medal final.</mark>

#### Short Stirrup Equitation Medal

- A. Junior members ages 10 and under as of 12/1 of the previous year are eligible for the Short Stirrup Equitation Medal Final.
- B. To be eligible for the Short Stirrup Equitation Medal Final, a rider must have received at least twenty (20) points (red merit) in the Short Stirrup Equitation Division prior to the Benefit Show.
- C. A rider may accumulate points in both the Short Stirrup and Long Stirrup Equitation divisions during the competition year, but must select only one medal final class in which to participate.
- D. A rider may only ride in one medal final per year; i.e. a rider may not ride in the Harford Hunt Seat Medal Final and the Short Stirrup or Long Stirrup Equitation Medal Finals in the same year.
- E. Exhibitors must be paid members of HHSA prior to entering the ring.
- F. To be shown over a course of a minimum of six (6) fences. Fences are not to exceed 18" in height.
- G. Judge is to select eight (8), if available, to show at a walk, trot, and canter both ways of the ring. This is mandatory at the year-end finals.
- H. Judged on hands, seat, guidance, and control of mount throughout.
- I. The same mount and tack must be used in all phases (i.e. saddle, bridle, bit, spurs, crop, etc).
- J. Martingales are permitted in the over fences phase, but prohibited in the under saddle phase.

#### Long Stirrup Equitation Medal

- A. Members ages 11 and older as of 12/1 of the previous year, or riders ages 9 or 10 as of 12/1 of the previous year that ride a mount exceeding 14.2 hands, are eligible for the Long Stirrup Equitation Medal Final.
- B. To be eligible for the Long Stirrup Equitation Medal Final, a rider must have received at least thirty (30) points (red merit) in the Long Stirrup Equitation Division prior to the Benefit Show.
- C. A rider may accumulate points in both the Short Stirrup and Long Stirrup Equitation divisions during the competition year, but must select only one medal final class in which to participate.
- D. A rider may only ride in one medal final per year; i.e. rider may not ride in the Harford Hunt Seat Medal Final and the Short Stirrup or Long Stirrup Medal Finals in the same year.
- E. Exhibitors must be paid members of HHSA prior to entering the ring.
- F. To be shown over a course of a minimum of six (6) fences. Fences are not to exceed 2' in height.
- G. Judge to select eight (8), if available, to show at a walk, trot, and canter both ways of the ring. This is mandatory at the year-end finals.
- H. Judged on hands, seat, guidance, and control of mount throughout.
- I. The same mount and tack must be used in all phases (i.e. saddle, bridle, bit, spurs, crop, etc).
- J. Martingales are permitted in the over fences phase, but prohibited in the under saddle phase.

## V. Equitation Special Medal Classes

In order to be eligible to participate in the year-end equitation medal finals, a rider must accumulate twelve (12) points in a special medals class during the current competition year. Qualifying medal classes held during the year shall be scored on a cumulative basis.

All animals, in order to compete in any of the HHSA Medal Finals, must be registered with HHSA by 6/1 of the current competition year and have shown in at least one (1) HHSA pointed division prior to the yearend medal finals in the same competition year. If the animal is registered after 6/1, a \$20.00 late fee will be charged in addition to the set horse-recording fee.

Horses and ponies may only exhibit with one rider at the equitation medal finals. Additionally, each rider is only eligible to ride in one division at the medal final.

#### **USET Equitation Medal**

- A. Open to senior Amateurs, who are paid members of the HHSA prior to entering the ring, and have accumulated the required amount of points (12 points) in the special medal classes during the competition year.
- B. This is a special equitation medal class.
- C. Senior Amateurs may ride a pony or horse.
- D. Rider does not need to ride the mount they qualified on. However, all animals, in order to compete in any of the HHSA Medal Finals, must be registered with HHSA by 6/1 of the current competition year and have shown in at least one (1) HHSA pointed division prior to the year-end medal finals in the same competition year.

- E. When a rider has accumulated the required amount of points to be eligible to compete in the year-end finals, he/she may not enter the special medal classes at shows during the competition year again. Exceptions can be made for a qualified rider to compete when needed to fill the class at the discretion of the show management. The steward will be notified immediately.
- F. To be shown over a course of eight (8) fences with at least one change of direction. Fence heights offered are 2'3", 2'6", and 3', at the rider's discretion.
- G. Judge to select eight (8) riders, if available, to show at a walk, trot, and canter both ways of the ring. This phase is by judge's discretion for special medal classes at shows throughout the season, but mandatory at the year-end finals.
- H. Judged on hands, seat, and control of mount throughout.
- I. The same mount and tack must be used in all phases (i.e. saddle, bridle, bit, spurs, crop, etc).
- J. Martingales are permitted in the over fences phase, but prohibited in the under saddle phase.

#### **Open Adult Equitation Medal** (discontinued in 2018 season until further notice)

- A. Open to all seniors, who are paid members of HHSA that do not ride in any Amateur division during the current show year, and have accumulated the required amount of points (12 points) in the special medal classes during the competition year.
- B. This is a special equitation medal class.
- C. Seniors may ride a pony or horse.
- D. Riders do not need to ride the mount they qualified on. However, all animals, in order to compete in any of the HHSA Medal Finals, must be registered with HHSA by 6/1 of the current competition year and have shown in at least one (1) HHSA pointed division prior to the year-end medal finals in the same competition year.
- E. When a rider has accumulated the required amount of points to be eligible to compete in the year-end finals, he/she may not enter the special medal classes at shows during the competition year again. Exceptions can be made for a qualified rider to compete when needed to fill the class at the discretion of the show management. The steward will be notified immediately.
- F. To be shown over a course of eight (8) fences with at least one change of direction. Fence heights offered are 2'6" or 3', at rider's discretion.
- G. Judge to select eight (8) riders, if available, to show at a walk, trot, and canter both ways of the ring. This phase is by judge's discretion for special medal classes at shows throughout the season, but mandatory at the year-end finals.
- H. Judged on hands, seat, and control of mount throughout.
- I. The same mount and tack must be used in all phases (i.e. saddle, bridle, bit, spurs, crop, etc.).
- J. Martingales are permitted in the over fences phase, but prohibited in the under saddle phase.
- K. If entries warrant, this class can be combined with the USET Equitation special medal class, except at the year-end medal finals.

#### Harford Hunt Seat Equitation Medal

- A. Two distinct classes are to be offered at the year end finals:
  - 1. Harford Hunt Seat Child on a Pony (mounts 14.2 hands or under)
  - 2. Harford Hunt Seat Child on a Horse (mounts over 14.2 hands)
- B. The Harford Hunt Seat Equitation Medal Finals will be divided into a Harford Hunt Seat Child on a Pony Medal Final and Harford Hunt Seat Child on a Horse Medal Final. Throughout the show season, the Harford Hunt Seat Equitation Medal class may or may not be divided; only the Finals must be divided into horse and pony.

- C. Open to juniors who are paid members of the HHSA prior to entering the ring and have accumulated the required amount of points (12 points) in the special medal classes during the competition year.
- D. These are special equitation medal classes.
- E. Riders may show in Child on a Pony and Child on a Horse special medal classes during the regular competition season.
- F. When a rider has accumulated the required amount of points to be eligible to compete in the year-end finals, he/she may not enter the special medal classes at shows during the competition year again. Exceptions can be made for a qualified rider to compete when needed to fill the class at the discretion of the show management. The steward will be notified immediately.
- G. Rider does not need to ride the mount they qualify on. However, all animals, in order to compete in any of the HHSA Medal Finals, must be registered with HHSA by 6/1 of the current competition year and have shown in at least one (1) HHSA pointed division prior to the year-end medal finals in the same competition year.
- H. To be shown over a course of eight (8) fences with at least one change of direction. Fence heights to be offered are 2', 2'3", 2'6", 2'9", and 3' (per show management), at the rider's discretion.
- Judge to select eight (8), if available, to show at a walk, trot, and canter both ways of the ring. This phase is by judge's discretion for special medal classes at shows throughout the season, but mandatory at the year-end finals.
- J. Judged on hands, seat, guidance, and control of mount throughout.
- K. The same mount and tack must be used in all phases (i.e. saddle, bridle, bit, spurs, crop, etc.).
- L. Martingales are permitted in the over fences phase, but prohibited in the under saddle phase.

#### **Equitation Medal Final Tests**

A minimum of four (4) of the following tests will be required during the year-end finals. Any may be required in a special medal class during the competition year, per judge's discretion.

- A. Rein back
- B. Hand gallop and halt
- C. Figure-eight at a trot with change of diagonal
- D. Figure-eight at a canter with simple change of lead
- E. Work collectively at a walk, trot, and canter
- F. Pull up and halt between fences
- G. Jump fences on a figure-eight course
- H. Jump low fences at a walk, trot, or canter
- I. Ride without stirrups or drop stirrups and pick up stirrups
- J. Dismount and mount
- K. Turn on the forehand
- L. Figure-eight at a canter, demonstrating a flying change of lead
- M. Serpentine at a trot and/or canter with simple or flying changes of lead
- N. Change leads down center of ring with simple or flying changes of lead
- O. Canter on counter lead
- P. Turn on the haunches
- Q. Change of mounts (\*Test option for year-end finals <u>ONLY</u>)
